



<u>Renewal page</u> is now open! You can review your 2020-2021 membership renewal information via your Teacher Portal. Physical invoices will be delayed during the Shelter-In-Place.

The fastest way to renew your membership is by logging onto your <u>Teacher Portal</u> and paying online. You will receive an email confirmation of your renewal once completed.

During the current Shelter-In-Place in place order, we strongly recommend that you renew your membership online. The State Office is currently working remotely with limited access to mail. We are also not accepting renewals over the phone until the Shelter-In-Place order is lifted.

Membership renewals must be submitted by <u>July 31, 2020</u> in order to be eligible to maintain your membership, to enroll students in Certificate of Merit® 2021, and to be listed in the printed State Membership Directory.

Dear CM Teacher,

Thank you for your patience and understanding as CM Council, State Board, and State Office weighed several options of how to complete the Certificate of Merit® Evaluation Season for those students whose performance and/or theory exam were postponed. We considered many factors in making our decision, including adhering to state and local government mandates, the safety of our students, teachers, and evaluators, and maintaining the integrity of the Certificate of Merit® program.

The MTAC State Organization has decided to resume the performance portion of the exam in a video format and the theory exam will be hosted on an online platform. The testing will resume at the end of May and continue through June.

To comply with the social distancing mandates, students must record their performance portion and upload it to the audition platform. Evaluations for this year **will not** be live streamed with evaluators on platforms like Skype or Zoom.

For Strings, Winds, and Voice Evaluations: To comply with social distancing mandates, live accompaniment is not required. The teacher and student may select the option best for the student from the options below:

- Live accompaniment if someone in the household can adequately accompany the student
- Pre-recorded accompaniment or accompaniment program, such as SmartMusic
- No Accompaniment

The student's evaluation results will not be affected by the accompaniment choice.

Specific instructions for recording will be released soon along with submission dates and deadlines.

We hope this information helps you in your planning for your students' upcoming CM evaluations.

Music Teachers' Association of California[®] CERTIFICATE OF MERIT[®] VIDEO EVALUATION & THEORY TEST INFORMATION

The remainder of the Certificate of Merit 2020 Evaluation Season will be conducted by video submission. MTAC has partnered with Acceptd, an online platform for auditions and competitions. An Acceptd account is required in order to upload performance videos. The creation of the Acceptd account is free and submission of the evaluation videos is included in the CM registration fee. *More information regarding creating an Acceptd account and uploading videos into the Acceptd platform will be provided when your Branch's upload deadline is scheduled*.



Video Instructions:

- 1. Video recording should be good quality, but does not need to be professionally produced. Recording with a smartphone would be an acceptable method of recording.
- 2. Video recordings must be made with one fixed camera angle, focused on the performer(s) with face and hands of contestant visible. Please see the images of recommended views for each instrument type at the end of this document.
- 3. Students should dress as they would for a live, in-person evaluation.
- 4. Students will submit a separate video for each of the following components of the performance evaluation:
 - • Technique

o Piano students may only have the technique chart on the piano. *No written out notation is allowed*.

o String, Wind, and Harp students must turn the music stand toward the camera to show that only the technique chart is on the music stand, then turn it back to play. *No written out notation is allowed*.

- Sight Reading This aspect has been waived for this year.
- Repertoire one recording for each piece

• Each piece should be played in its entirety, without stopping

 $\circ~$ All recordings do not need to be completed on the same day, but must be completed and submitted by the deadline.

• Repertoire previously recorded by the student, such as during a "pre-CM" studio recital, may be used for this evaluation.

o Memorization - pieces performed from memory should have all music removed from the piano or the music stand removed (for non-piano students).

- 5. Video recording must be unaltered and unedited.
- 6. The file name on the submissions must include the student's application ID and composer last name or component of the evaluation. (for example, 7XXXXX Technique, 7XXXXX Bach, etc.)

7. Repertoire Changes: Due to the postponement, students are permitted to change repertoire, except for the piece designated as the "Syllabus Piece."

• While maintaining the correct repertoire categories is best, students will not be penalized if changes no longer comply with the required repertoire categories.


- No updates are necessary in the repertoire portion of the student's application in the MTAC Online System
- 8. **For Strings, Winds, and Voice Evaluations:** To comply with social distancing mandates, live accompaniment is not required. The teacher and student may select the option best for the student from the options below:
 - Live accompaniment if someone in the household can adequately accompany the student
 - • Pre-recorded accompaniment or accompaniment program, such as SmartMusic
 - No Accompaniment The student's evaluation results will not be affected by the accompaniment choice.
- 9. For Piano: Students will be evaluated based on their performance, not on the type of piano or keyboard used, or whether it was recently tuned.
- 10. Video recording can be completed in a studio, home, school, or any location of the student's choice, but should abide by any current shelter in place and physical distancing mandates.
- 11. Video Recordings must be uploaded by 11:59PM on the due date assigned to the student's Branch .

12. Results will be entered into the MTAC Online System and available through the Parent/Student Portal within 2 weeks of the submission deadline.

Online Theory Exam:

Students will complete their theory exam on an online testing platform. The test will be in a multiple choice and short answer format. The listening examples of the ear training portion of the exam will be included in the exam.

Visual Example of How to Frame Your Video:



Do you know which camera angles are correct?



- 1. Piano students are recommended to angle their camera so that it focuses on their hands on the keyboard and the pedals.
- 2. For strings and winds students, students must have the music stand facing the camera.
- 3. For guitar and harp students, we recommend that the camera faces the students straight on.

What you'll need for online lessons

It's easy and you can most likely just use the equipment you already have!

- 1. Laptop, tablet or smartphone with the camera set up like the photo below (or close to this).
 - a. A Laptop or Tablet is preferred, since the screen will be bigger.
 - b. Zoom software downloaded onto the device *in advance* of the first lesson. You can download Zoom online at zoom.us and/or download it from the app store onto your phone or tablet. Choose "Zoom Cloud Meetings" to download from the app store.
 - c. Pencil, eraser, 3 different color highlighters or colored pencils at the piano/keyboard. Please also have page flags for marking the pages to practice.
 - d. A metronome
 - e. A Parent standing-by or observing for at least the first few lessons (particularly for younger children), possibly longer if it's helping the student practice at home and/or stay focused.
 - f. Meeting ID # _____ placed somewhere easy to see or find.
- 3. High speed internet connection.



I take notes and text or email them to you each week so the student has an assignment sheet. Please print these off so the student knows what to practice each week.

For best results, please turn off all other applications before starting the lesson and if possible, keep others on your wifi from streaming video during the lesson. If you know you have fast internet, then the latter might not be an issue. But if you know in general that your internet is not the fastest, or if you usually experience "freezes" on your screen when trying to stream video, you will want to consider keeping others off streaming videos on other devices during the lesson.

ASCAP Submissions: Do the Right Thing.

Did you know that US Copyright Law states that composers must receive a royalty when their work is performed? ASCAP protects the rights of its members by licensing and distributing royalties for the performances of copyrighted works.

ASCAP members make their living writing music, many of whom are also MTAC members. ASCAP exists to ensure that music creators are paid when their works are performed publicly. Rental or purchase of sheet music does not authorize its public performance.

MTAC has an ASCAP Copyright License, and covers each and every MTAC member for all branch and individual performances. However, in order for ASCAP members to receive royalties from the performances of their works, we must submit programs to the state office. This is where I need your help.

Throughout the 2019-2020 season, I'll collect TWO copies of each program and send them to the MTAC state office on June 30. As a reminder, these can be studio recitals, masterclasses, festival, and any other performances.

For the convenience of our branch members, there are several ways to submit your programs:

1. Send them to or drop them off at my home: Caitlin Boruch, 1258 Rotella Street in Newbury Park, CA 91320.

2. Give them to me if you see me in any capacity (MTAC festivals, performances, around town). It is the responsibility of the festival chairs to turn in the programs, but at the festivals where my students perform, I'm happy to arrange to pick up the two copies of every performance.

3. Collect them throughout the season and hand them to me at the MTAC luncheon and general meeting in May.

ARTICLE VI BRANCH OFFICERS

Section 4. President; Qualifications. Music Teachers' Association of California[®] VOCE SOLO VIDEO RECORDING SUBMISSION POLICIES

- 1. The VOCE Finals Competition will be conducted by video submission. MTAC has partnered with Acceptd, an online platform for auditions and competitions. An Acceptd account is required in order to upload performance videos.
- 2. VOCE Finalists will submit a video performance of the same repertoire listed on the original application and performed at the Branch VOCE Competition. Changes in repertoire will lead to disqualification.
- 3. Video Recording must be uploaded by May 15, 2020 at 11:59 PM.
- 4. VOCE Judges will review the video submissions and make final decisions for the competition.
- 5. Results will be posted on June 1, 2020.

Video Submission Instructions

- 1. One (1) video recording must be uploaded to the Acceptd portal by **May 15, 2020**. Video recording must be a maximum of ten (10) minutes of music and include two (2) musical selections per the VOCE Policies and Procedures:
 - a. All videos are to begin with a sign showing their application IDs and the date of the video. Applicants are not to introduce themselves.
 - b. All videos are to have been recorded between March 27 and May 15, 2020.
 - c. The main piece should be recorded first and can be up to seven (7) minutes with cuts and if appropriate, the cadenza.
 - d. The second piece should be at least 2 1/2 to 3 minutes.
 - e. The file name on the submission must include the application ID.
 - f. Solo Vocalists are allowed the use of recorded accompaniment. This does not extend to other instrumentalists.
- 2. Video recording can be completed in a studio, home, school, or any location of the student's choice.
- 3. Video recording must be high quality, but does not need to be professionally produced.
 - a. Be aware of any distracting background noise that can take away from the piece.
 - b. Check the recording before uploading it to the online applications.
 - c. Participants should dress as if you will be performing at a recital.
 - d. Present the song as it is meant to be heard in front of a live audience.
- 4. Video recording should be played without stopping.
- 5. Video must contain all repertoire listed on the original application.
- 6. Video recording must be made with one fixed camera angle, focused on the performer(s) with the face and hands of contestants visible. No conductors are allowed.
- 7. Check videos for sound and picture quality before uploading.
- 8. A high-speed internet connection is recommended for upload.
- 9. Chrome is the preferred browser of Acceptd. Any issues with the Acceptd upload should be directed to support@getacceptd.com.

Annual Women Composers Festival in late September.

Dear Colleagues,

I hope this email finds you and your families healthy and safe.

I hope that we will be able to have our annual Women Composers Festival this fall, in late September. The purpose of the festival is to explore the music of women composers. The festival is open to all instruments and voice, and to all CM levels. Chamber ensembles are very welcome. Memorization is optional. The only requirement is that the piece(s) be written by a female composer. Students will introduce the composer of their piece before performing it. 3-4 sentences are enough, but more is fine too.

I'd like to encourage you to start thinking about repertoire for your students. While the pedagogical composers are welcome, it would be really great to have a wider variety of women composers from throughout music history. It would also be good to have composers from Latin America, Asia, Australia, and Africa represented, as well as the usual suspects from North America and Western Europe. For example, it would be fantastic for some of the vocal students to sing some Hildegard of Bingen. There are several female European Baroque composers who wrote for keyboard, flute, and strings: Anna Bon, Princess Anna Amalia of Prussia, Elizabeth Jacquet de la Guerre, and more. And of course from the Romantic period we have Clara Schumann, Louise Farrenc, Mel Bonis, and Cecile Chaminade. I will send an email with a short list of other composers with a larger geographic range. These days of course, you can just google "women composers clarinet" or whatever instrument, or "Japanese women composers" for instance, and you will meet intriguing results.
